## **INTRODUCTION**

NERAMAC is a Central Govt. of India Enterprise under the administrative control of MoDONER. It was set up to support farmers/producers of **NORTH EAST** getting remunerative prices for their produce and thereby bridges the gap between the farmers and the market and also to enhance the agricultural, procurement, processing and marketing infrastructure of the Northeastern Region of India.

**ONE OF MAJOR OBJECTIVE OF NERAMAC IS ALSO TO MAKE TIMELY AVAILABLE GOOD QUALITY SEEDS, BIO-FERTILIZER, BIO-PESTICIDE AND OTHER AGRI-INPUTS TO ENHANCED THE PRODUCTIVITY OF THE FARMERS. NERAMAC BEING ACTIVELY INVOLVED IN PROMOTION AND MARKETING OF ORGANIC AND HEALTHY AGRICULTURE PRODUCE AND SUPPORT THE MOVEMENT OF ORGANIC FARMING AIMS TO PROVIDE GOOD QUALITY CHEMICAL FREE AGRI-INPUT TO FARMERS**

### **1. Scope of Work**

The scope of work for the empanelled Agency shall be as under:

Reputed Manufacturing company/ Firm shall be empanelled based on the qualifying criteria and products of successful manufacturers shall be offered to the Central & State govt. / Departments. The period of empanelment is Limited for specific period not more than one year or till the time successive empanelment is done, whichever is earlier. Manufacturer's are solely responsible for the any product liability and supplies whatsoever. NERAMAC by registering these reputed manufacturers shall act as representative of these companies in NER, states of UP, Odisha and others, so that quality products can be made available timely and in best rate to the farmers of NER and other states

### **2. Qualifying Criteria:**

- a) The minimum turnover of the company in regard to Supply of Bio fertilizer/ Bio Pesticide should be average Rs. 500 Lakhs per annum each for last 3 years. The turnover of Supply of Bio fertilizer/ Bio Pesticide division should be reflected in balance sheet/billing details certified by the chartered accountant. In case this turnover is not reflected separately in the balance sheet, a certificate in respect of the turnover of the Supply of Bio fertilizer/ Bio Pesticide division by the chartered accountant of the company should be enclosed.
- b) The company must have work experience of at least five years in Manufacturing/ Supply of Bio fertilizer/ Bio Pesticide.
- c) For Bio-fertilizers, Company should comply as per norms and rules of Latest Fertilizer control Order (FCO)
- d) For Bio-Pesticides, Company should comply by all norms and rules of Latest Central Insecticides Board and Registration Committee (CIB&RC).

- e) Bio-Fertilizers and Bio- Pesticides should be in compliance for use in organic production as allowed/ restricted product under NPOP and should be certified by APEDA registered certifying agencies.
- f) The applicants must have proper infrastructure for distribution of above items even at the block level of all the districts of applied States of North East Region & Uttar Pradesh as per instruction of NERAMAC and/or ordering authority and in this case it is state of Uttar Pradesh, North East Region.
- g) The Agency should have equipped with adequate, qualified & experienced manpower on rolls & infrastructure.
- h) The Agency should have undertaken at least 5 such Supply of Bio fertilizer/ Bio Pesticide during last 5 years for PSU's, Autonomous Bodies, Corporate & Government and at least 3 successful executions of orders worth Rs. 200 Lakhs
- i) Should not be blacklisted by Central or State Government or Government Organisations/Agencies.
- j) Applicants are required to submit solvency certificate from the bank for a minimum average balance of Rs. 25 lacs alongwith EOI application. The banker's certificate in this respect issued before 01/01/2017 will not be accepted.

### 3. Desirable Criteria

- a) Preference shall be given to firm/ company who has manufacturing facilities in North East Region.
- b) Preference shall be given to firm/ company which has experience in supplying to any Govt. agencies, PSU, State Govt., or Govt. owned federation etc. the same to be certified by the Chartered Accountant along with his seal & signature.

### 4. GENERAL TERMS AND CONDITIONS

- a) **Document Fee** : The applicant should submit the documentary evidence of Document fee of Rs. 1000/- (Rs. One thousand only) for alongwith EOI application. The Demand Draft shall be in the name of **MD, NERAMAC, 9 Rajbari Path, G.S Road, Guwahati – 781005, Assam, (India)**. The fee shall be non refundable.
- b) **Processing Fee**: The applicant should submit the documentary evidence of Document fee of Rs. 20,000/- (Rs. Twenty thousand only) for alongwith EOI application. - d) The EOI documents in Format – duly completed in all respect and duly signed by the authorized persons alongwith Xerox attested copy of required documents and empanelment fee is to be dropped in the EOI BOX available at the above address. and the same will be opened on same day at 14.00 hrs. in presence of applicants or their authorized representatives.
- e) Each page of EOI documents as well as corrigendum, if any, must be signed with date and seal failing which the tender shall be liable to be rejected.
- f) EOI received with incomplete /partial information and/or without supporting documents shall be liable to be rejected at the discretion of the EOI inviting authority.
- g) No upwards price variation will be allowed during the validity of the EOI.
- h) NERAMAC is not bound contractually or in any other way to any applicant(s) to this Expression of Interest. NERAMAC is not liable for any costs of compensation in relation to the consideration of this Expression of Interest, incurred by the applicant(s) to this Expression of Interest whether or not NERAMAC terminates, varies, or suspends the Expression of Interest process or takes any other action permitted under this Expression of Interest.
- i) **Payment Terms:** 90% Payment of invoice value of the Manufacturer's to be made within 30 days from the date of receipt of payment from buyer and completion of all formalities inclusive of NOC/ Successful execution certificate from the Buyer whichever is later. Balance 10% shall made within 3 months from the date of 1<sup>st</sup> payment.
- j) The applicant shall furnish an undertaking in support of their claim and information /documents submitted. If anything found false in course of verification , at any point of time and/or after approval of the enlisted firm shall be blacklisted and debarred from future transactions with The Odisha Agro Industries Corporation Limited and also liable for payment /compensate any loss arise due to false undertaking.

- k) No new partner/partners shall be accepted in the firm by the firm in respect of the contract unless he/they agreed to abide by all its terms, conditions and deposit with the department with a written agreement of this effect. The contractor/firms receipt for acknowledgement or that of any partners subsequently accepted as above shall bind all of them and shall be sufficient discharge for any of the purpose of the contractor.
- l) Sales Tax Registration and Clearance Certificate: No firm who is not registered under the Sales Tax Act prevalent in the State, if applicable where his business is located shall tender. The Sales Tax Registration No. should be quoted and a sales tax clearance certificate from the Commercial Taxes Officer of the Circle concerned shall be submitted without which the tender is liable to rejection.
- m) Copies of service tax registration & latest clearance certificate should be enclosed.
- n) Tender form shall be filled in ink or typed. No tender filled in pencil shall be considered. The tenderer shall sign the tender form at each page and at the end in token of acceptance of all the terms & conditions of the tender.
- o) Applying against Expression of interest (EOI) does not automatically give right to empanelment / registration
- p) All costs incurred by the agency in respect of submission of offer and presentation shall be borne by the agency concerned.
- q) All the applicants should be certified by APEDA registered certifying agencies.
- r) Agreement and Security deposit: Successful empanelled agencies shall have to execute an agreement as specified within 10 days from the date of dispatch of acceptance letter of the tender. EMD of successful empanelled parties shall be automatically adjusted against performance guarantee/ security deposit.
- s) NERAMAC reserves the right to remove any agency/organisation/society from the empanelled list along with forfeiture of Performance Security, if the service provided by them is found to be unsatisfactory or if the information provided for empanelment is proved to be false.
- t) **SETTLEMENT OF DISPUTES** : All disputes or differences in relation to the EOI, the contract or the interpretation of any of their terms or implementation there-of or arising out of or concerned directly or indirectly with the contract shall be referred to the arbitration or a single arbitrator to be appointed by the Managing Director of the Corporation and in the absence of MD, the highest Executive Officer of the Corporation shall make such appointment. The venue of arbitration shall be at Guwahati. The court of law at the Guwahati alone will have jurisdiction in the matter of any disputes whatsoever.

## **5. QUALITY AND QUANTITY :**

For Bio-fertilizers, Company should comply as per norms and rules of Latest Fertilizer control Order (FCO). For Bio-Pesticides, Company should be comply by all norms and rules of Latest Central Insecticides Board and Registration Committee (CIB&RC). Bio-Fertilizers and Bio- Pesticides should be in compliance for use in organic production as allowed/ restricted product under NPOP and should be certified by APEDA registered certifying agencies.

- a) NERAMAC may draw representative samples of the final product offered by the Manufacturers and may have them analyzed in any accredited Test Laboratory (QCL) or any other laboratory identified by NERAMAC.
- b) NERAMAC will draw samples for 25% more quantity than the supply order, to ensure that in the event of failure of any lot in Laboratory there is no short fall in the supply from the ordered quantity. NERAMAC may draw representative samples of the finally packed seed lots and have them analysis in NERAMAC's Quality Control Laboratory (QCL) or any other laboratory identified by NERAMAC. If such lot does not meet the standard, NERAMAC may refuse to accept these seed lots quantity.
- c) Manufacturer shall bear the cost of Test and which may be deducted from first installment.
- d) Manufacturers will provide the certification tag, thread, seal essentially and arrange the packing, sealing, labeling, tagging, stacking and loading at his cost, besides arrangement of packing materials like bags & labels etc.
- e) Tenderer failure to arrange the supply as per the Terms & Conditions will entitle NERAMAC to cancel the order and arrange from the next party in the tender at the cost and risk of the defaulting tenderer.
- f) In the event of any dispute / complaint with reference to the product quality, if the responsibility of the Manufacturers is proved / established, he shall bear the loss / damage, if any, sustained by NERAMAC to the relevant extent. The Manufacturers shall, at his cost, take back part or full quantity of such stock proved defective on receipt by NERAMAC / delivery to NERAMAC. Manufacturers shall indemnify NERAMAC fully including the any compensation or litigation on NERAMAC against the Quality and Quantity of product supplied.
- g) Procurement shall be done only for the quantity for which NERAMAC has confirmed demand. If required, NERAMAC may repeat the order for the additional quantity within two months from the date of security deposit remittance with mutual consent

## **6. Procedure for Selection and supplies :-**

- a) All the applications received in response to the notice for EOI will be scrutinized by the Evaluation Committee of NERAMAC on the basis of qualifying criteria as per the Technical Bid given in EOI.
- b) **Procedure for Supplies** : Products and prices of Successful empanelled parties shall be offered to Central / State Govt. department/ Agencies after adding trading and other charges for NERAMAC over and above prices given by manufacturer. Considering their requirement and availability of offers already with them, Department shall place indent to us. On receipt of confirmed Order from the Central/ State Govt. Department/Agencies based on Brand, Prices, Quality and services of the products and the company selected by the buyer a letter of Intent shall be offered to the Manufacturers and it is required to submit a Performance Guarantee of 10% of the order value within 7 days from receipt of LOI.
