Tender Document:-Tenderer has to purchase the tender form by depositing an amount of Rs.500/-(Rupees five hundred) only by cash being the cost of the tender form the office Cashew Processing Plant, Teldhala, P.O - Borkona, Dist - Dhubri, PS - Mankachar, Pin: 783131, Assam during office hours from 10 AM to 5.30 PM on any working days up to 6th January, 2017.

The tender form may also be downloaded from the website of NERAMAC i.e. <a href="https://www.neramac.com">www.neramac.com</a> and the cost of tender form of Rs. 500/- may be submitted along with rate offer in the form of demand draft / Bankers cheque drawn on any scheduled bank in favour of NERAMAC Ltd. payable Guwahati, in absence of which the bid shell be treated as cancelled.

- 2) **Rate**: The rate should be quoted for the full quantity of cashew-nuts which is inclusive of CST/VAT as the case may be.
